In case of sell out of a particular lead retrieval unit Designer Pages, LLC. reserves the right to substitute at the same or lower price. Advance deadlines are stated on the order form. Orders must be completed and payment must be received on or before the deadline date to partake in any special pricing/promotions. If orders are received after the deadline and indicate pre-deadline pricing, Designer Pages, LLC (DP) reserves the right to charge the post-deadline price.

The contact person has been informed by DP that the systems can be used to collect information provided by attendees on their registration forms, from the registration database such as; Attendee Name, Title, Company, Address, Phone, Fax, E-Mail (if provided to Show Management), etc. Information included is subject to the information designated by each event's management to be captured and may vary from event to event. Contact/User person understands and accepts that some badges issued by show management, at on-site registration, may not have bar codes and unique id numbers to allow for expedience during on-site registration.
